**SUMMARY OF COVERAGE** 

#### **Coverage 01 Cancellation or Postponement**

Cancellation or Postponement coverage will pay, up to the coverage limit and deductible that you select, the nonrefundable expenses incurred when the rehearsal, rehearsal dinner, wedding or private event, reception or honeymoon, must be canceled or postponed for certain reasons beyond your control. Limited innocent party Change of Heart coverage is also available in most states. These reasons include but are not limited to sickness or injury to the bride, groom, or for other private event types, the Honoree (the person(s) if any, for whom the event is being held); damage to the premises where the wedding or private event is to be held; loss or damage to the bridal gown; the cancellation of a written military leave of absence; and job loss. Also covered are weather conditions which prevent the bride, groom, or for other private event types, the Honoree, or the majority of the guests from reaching the premises where the wedding or private event is to take place. Weather coverage is available only if the policy is purchased 14 or more days from the date of the first event. Failure-to-show of the caterer or, the person engaged to perform the ceremony is covered for Cancellation or Postponement. Closure of the ceremony site or reception site due to financial failure is also covered for Cancellation or Postponement.

# Basic Policy includes \$1,000 of Cancellation or Postponement Coverage.

#### **Coverage 02 Additional Expense**

Additional Expense coverage will pay up to 25% of the limit that you select for Coverage 1 Cancellation Or Postponement for any additional expenses necessary to arrange alternate services to avoid a covered cancellation or postponement of the wedding, private event, reception or related event. **Basic Policy includes 25% Additional Expense Coverage** based upon the Cancellation or Postponement Coverage Selected.



# **Coverage 03 Photographs And Video**

Photographs and Video coverage will pay, up to the coverage limit and deductible that you select, to retake photographs if the photographer fails to appear or, the original negatives are lost, damaged, stolen or not properly developed. This coverage will pay the round trip air or auto travel expenses incurred by the bride, the groom, or for other private event types, the Honoree, and their immediate families and attendants, to reassemble for the ceremony pictures to be retaken. It will also pay costs for meals and lodging while traveling, costs to rehire a photographer, costs to rent a premises to stage the ceremony pictures, costs to buy new flowers, and costs to rent necessary wedding or special attire.

# **Basic Policy includes no Photographs and Video Coverage.**

Gifts coverage will pay, up to the coverage limit and deductible that you select, to repair or replace gifts which are lost, stolen or damaged anywhere within the policy territory. A police report is required for stolen gifts.

# **Basic Policy includes no Gifts Coverage.**

#### **Coverage 06 Special Attire**

Special Attire coverage will pay, up to the coverage limit and deductible that you select, to repair or replace the bridal gown and other special attire, when it is lost, stolen or damaged (including financial failure of the bridal store) within the policy territory. Special attire includes the clothing and accessories bought or rented and to be worn by the bride, the groom, or for other private event types, the Honoree, and their attendants at the wedding or private event ceremony. It does not include watches, jewelry or precious or semi - precious gemstones or pearls (even if attached to clothing), c overage for which may be purchased under the Jewelry section of this policy. A police report is required for stolen special attire.

# **Coverage 07 Jewelry**

Jewelry coverage will pay, up to the coverage limit and deductible that you select, to repair or replace jewelry you own when it is lost, stolen or damaged anywhere within the policy territory. A police report is required for stolen jewelry.

Loss of Deposits coverage will pay, up to the coverage limit and deductible that you select, lost deposits that you have paid if they become non -refundable as a direct result of anyone hired to provide goods or services going out of business.

Professional Counseling coverage will pay, up to the coverage limit and deductible that you select, for professional counseling prescribed by a medical physician and resulting from a covered cancellation.

### **Basic Policy includes no Professional Counseling Coverage.**

#### **Coverage 10 Personal Liability**

Personal Liability coverage will pay up to the coverage limit and deductible t hat you select, toward the sums for which you become legally responsible, as the result of bodily injury, personal injury or property damage caused by a covered accident which occurs during the course of a covered event such as the rehearsal, rehearsal dinner, ceremony or reception. Additional Insured endorsements and Certificates of Insurance may be issued at any time upon your request and can include the name of your corporation. Of special importance to you and to the event sites, liability coverage available on this policy which is not available on other liability policies would include Property Damage Liability for certain property in your care, custody or control. This very special coverage includes Property Damage Liability resulting from damage to the premises which you hire as the sites where the covered events are to take place. Host Liquor Liability is included.

Basic policy includes \$1,000,000 per occurrence and \$2,000,000 aggregate personal liability coverage.
